SECTION 4: First aid measures

4.1. Description of first aid measures

Do not perform artificial respiration without self-protection (e.g. a mask). Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If inhaled

Take care of your own safety, do not let the affected person walk! Terminate the exposure immediately; move the affected person to fresh air. Beware of the contaminated clothes. Depending on the situation, call the medical rescue service and ensure medical treatment considering the frequent need of further observation for at least 24 hours.

If on skin

Remove contaminated clothes. Wash the affected area with plenty of water, lukewarm if possible. Soap, soap solution or shampoo should be used if there is no skin injury. Provide medical treatment if skin irritation persists.

If in eyes
